Generally, the more open access content published in a journal, the lower the future online-only price.

Development of a digital repository for NLM's digitized collections and born-digital resources

The Digital Repository Evaluation and Selection Working Group (DRESWG) was established to evaluate commercial systems and open source software and select one (or combination of systems/software) for use as an NLM digital repository. (In April 2006, the Acting Associate Director for Library Operations appointed the NLM Digital Repository Working Group (DRWG) and charged them with the task of developing functional requirements for an NLM digital

Wiley: The full texts of all Current Protocols and most reference works have been indexed by Google

Starting late in May 2007... similarly to the books an journals on Wiley InterScience. This means that a Google keyword search will now lead a user straight to the articles which feature this keyword anywhere in the full text. The increased discoverability of the content has immediately led to an increase of demand: Full text access to the reference works were 24% higher in June than May and Access Denied counts even increased by 504%!

Nonprofit publishers oppose government mandates for scientific publishing

A coalition of 75 nonprofit publishers opposes any legislation that would abruptly end a publishing system that has nurtured independent scientific inquiry for generations. One such measure, the Federal Research Public Access Act, introduced in the 109th Congress, would have required all federally funded research to be deposited in an accessible

database within six months of acceptance in a scientific journal. Some open access advocates are pressing for the introduction of a similar measure in the 110th Congress.
